THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

A-30 Class Deck "PAROC Marine Fire Slab 100, 25/25 mm"

A-30 class steel deck with the bottom face insulated with stone wool panels "PAROC Marine Fire Slab 100" manufactured by Paroc Group Oy, Finland having the nominal density of 100 kg/m³. The insulation is applied in one layer. Between the stiffeners the thickness of the insulation layer is 25 mm. Upon the stiffeners the thickness of the insulation is 25 mm. A suitably shaped piece of rockwool is fitted within the stiffeners. The insulation is fastened with steel pins and washers.

Maximum distance between fastening pins:
300 mm in height.
300 mm in width.
100 mm at the horizontal junction of blankets.
150 mm on each side of stiffeners.

2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawing n°355917.

3. TEST REPORTS:

Test report n°2000CSTO1556/3 dated March 8, 2001 as per IMO FTP Code Annex 1 Part 3 [testing standard: IMO Resolution A.754 (18)] issued by the Fire Protection Research Laboratory of RINA, Italy.

4. APPLICATION / LIMITATION:

- 4.1 - Approval also valid for ships having to comply with the HSC Code, for a structural fire protection time of 30 minutes: "Load bearing steel fire-resisting deck 30";
- 4.2 - The insulating material "PAROC Marine Fire Slab 100", as well as any added surface finish material(s) shall have to comply with the requirements of BV Rules and be type approved .
- 4.3 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

- 5.1 - The A-30 Class Deck "PAROC Marine Fire Slab 100, 25/25 mm is to be supplied by PAROC GROUP Oy, HELSINKI - FINLAND in accordance with the type described in this certificate.
- 5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320.
- 5.3 - PAROC GROUP Oy, HELSINKI - FINLAND has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products:
